

2019 Development Committee Annual Report

The Tri-Valley Development Fund received contributions from 44 employees through the payroll deduction option during the 2019 fiscal year. In addition to payroll deduction funds, additional credit card payments and one-time donations were given by outside individuals and businesses. At the close of fiscal year 2019, a total of \$4,780.90 had been donated to the Tri-Valley Development Fund, bringing the total Development Fund to \$10,182.49. Funds were distributed throughout 2019 totaling \$5,113.65 for lobbying (lobbying dues are to support legislative advocacy and lobbying on Tri-Valley's behalf through MinnCAP and the National Migant & Seasonal Head Start Association). In addition, donations were made to the National Head Start Association (Dollar Per Child Advocacy Campaign), Power of Produce (POP) Kids Club, the Early Childhood Initiative and to our co-workers who had been affected by an unforseen emergency during the year.


